Explanation of Responses:

1. Represents the number of shares of common stock issued upon the vesting of a restricted stock unit ("RSU") plus the number of shares of common stock accrued with respect to such vested portion of the RSU as a result of dividend equivalent rights paid by the Company pursuant to the terms of the award, less fractional shares, which were paid in cash upon settlement.
2. RSUs convert into common stock on a one-for-one basis.
3. 17,500 shares held indirectly by a trust have been previously reported incorrectly as being acquired and held directly by the Reporting Person. Such shares are now reported correctly in row 2 of Table I.
4. Each RSU represents a contingent right to receive one share of common stock.
5. The RSUs were granted on May 7, 2019 and vest in full on the first anniversary of the grant date.
6. Represents only the RSUs granted on May 7, 2019 and does not include RSUs with different vesting terms.
7. Represents the number of shares of common stock issued upon the vesting of an RSU plus the number of shares of common stock accrued with respect to such vested portion of the RSU as a result of dividend equivalent rights paid by the Company pursuant to the terms of the award.
8. The RSUs were granted on May 8, 2018 and vested on the first anniversary of the grant date.
9. Represents only the RSUs granted on May 8, 2018 and does not include other RSUs with different vesting terms.

Lynch, Sarah Kim and Hina M.D. Patel, as the undersigned's true and lawful attorneys-in-fact, with full power to act without the others on behalf of and as attorney for the undersigned, for the following purposes:
